

## ENTRY VISA REQUIRMENTS FOR OMAN

Nationals of 105 countries and regions are exempt from entry visas for stays up to 14 days. The exemption is subject to certain requirements including a prior and confirmed hotel booking and a return ticket.

Citizens of GCC countries (the Kingdom of Bahrain, the State of Kuwait, the State of Qatar, the Kingdom of Saudi Arabia and the United Arab Emirates) do not require visas to enter Oman.

Nationals who are [underlined and blue color](#) are eligible for visa in the condition of obtained an entry visa to countries (the United States of America, Canada, Australia, the United Kingdom, Schengen Countries

and Japan, or have residency in one of the Gulf Cooperation Council countries and his profession is one of the professions benefiting from the resident visa)
